Coverage Checker

We're currently working on an integrated coverage checker, the first phase of which is in beta testing and should be available soon. This will allow you to determine line of sight between your Access Points and a potential customer, taking into account factors like Fresnel zone clearance and path loss.

Recently-Completed Features

Overage Billing Time of Day Restrictions

An enhancement to the Overage Billing feature has been added which allows an operator to define days and times when data usage is not counted against a customer's data cap. This allows an operator to charge for data usage during peak times, but to allow unlimited usage during off-peak times. Both the Customer Details page and the End-User Portal show the amount of data which counts against a customer's data cap, and the amount that was used during the exempted period.

Automatic Update of Equipment Hierarchy

A new feature has been added to the SIMPLer system that allows operators to scan their network periodically to search for Subscriber Module <-> Access Point associations, and to update the "Parent" field of the Subscriber Module's equipment record automatically if a matching Access Point is found within the SIMPLer system. When a match is found, the "Site" field in the customer record of the customer associated with the Subscriber Module is also automatically updated. If a Subscriber Module's corresponding Access Point is not found within the SIMPLer system, a notification email is sent to the operator's "Maintenance Email" address.

This feature allows the equipment hierarchy to be automatically maintained, which is extremely useful in diagnosing customer issues, and ensuring that emails sent using the Mass Email Notification tool go to all affected customers.

Support for Payment Express

SIMPLer has been enhanced to support the <u>Payment Express</u> payment gateway. This includes a token-based facility, where credit card details are stored directly in the Payment Express system. Our other supported payment gateways are: <u>Authorize.Net</u>, <u>IP</u> Pay, <u>Moneris</u>, <u>Realex</u> and <u>PayPal</u>.



Upcoming Features

Work is currently in progress on the following features:

Coverage Checker

See above for a description of the first phase of our Coverage Checker, which is currently being beta tested. Further enhancements are also planned which will provide more detailed information, taking into account factors such as effective radiated power, antenna gain, antenna horizontal and vertical radiation characteristics etc.

Weekly Data Caps

To add further granularity to our Overage Billing feature, we're currently working on an enhancement which will allow operators to specify weekly data caps rather than monthly ones. This will allow operators greater flexibility when defining usage-based payment plans for their customers.

Enhanced Attachment Handling

The ability to add attachments to a customer record will be enhanced so that a folder structure is defined for each customer. Operators will then be able to drag and drop files from other sources directly into the relevant folder, and have them automatically show up on the corresponding Customer Details page.
